  - CIEs are available statewide with major concentrated efforts largely sponsored by Medicaid coordinated care organizations (CCOs) and health plans that are then extended to community partners for use. The two prominent CIE vendors in Oregon are Connect Oregon (aka Unite Us) and findhelp. Utilization varies across the state.
- The Oregon Health Authority, Public Health Division, Health Promotion and Chronic Disease Prevention section is contributing to Comagine Health’s Administration for Community Living (ACL) grant to establish and scale the Community Integrated Network of Oregon (CINO).
  - The State Health Department participates on the Steering Committee with OHA staff and on various subcommittees to support work.
  - The ACL grant is a 3-year initiative to establish and scale the Community Integrated Network of Oregon (CINO) to strengthen infrastructure for community-based CDSME program delivery, increase access and program reach for people most in need, and build a system that is sustainable.
    - Strategies include establishing pathways for referrals from healthcare providers for WWE with referrals to social care needs to address SDOH using Compass, Connect Oregon, and Welld.
    - Compass will serve as the primary workshop and data management tool for program delivery partners under this grant.
    - The Public Health Division owns the license and will contract with Comagine Health to manage Compass and provide TA to organizations.

- The Western New York Integrated Care Collaborative (WNYICC) is an integrated care network and the technical assistance center for delivery partners funded by the NY State Office for the Aging (NYSOFA) ACL CDSME grant.
  - They are the leaders in establishing referral systems with healthcare providers and receiving reimbursement for evidence-based programs in NYS.
  - More recently, they've started using the platform WellD (<https://www.welldhealth.com/>) for referrals, enrollment, reporting, reimbursement, etc.
